Executive Summary

SARS-CoV-2, the virus known to cause COVID-19, can cause outbreaks of severe respiratory illness among hospitalized persons, long-term care facility residents, and staff. Long-term care facilities (LTCFs) are susceptible to COVID-19 outbreaks due to congregate living environments, and often, individuals with underlying medical conditions.¹ The COVID-19 vaccine has been recommended for all healthcare facility staff and residents by the Centers for Disease Control and Prevention (CDC) since first being approved through the Emergency Use Authorization (EUA) in December 2020.^{2,3}

Achieving COVID-19 immunity through vaccination uptake is essential to protecting LTCF residents and staff.⁴ In accordance with the Advisory Committee on Immunization Practices (ACIP), healthcare workers and all LTCF residents were among the first populations targeted for the Phase 1a COVID-19 vaccines due to their high-risk status. Phase 1a was a way to prioritize and provide vaccinations to those who are considered high risk due to age, congregate living status, and working in medical facilities. While staff members are vital in protecting these populations, they do pose a risk of transmitting SARS-CoV-2 due to interactions outside their workplace. LTCF staff responsibilities often require close contact with residents and other staff, resulting in a higher risk of contracting and spreading COVID-19 in these settings. Vaccinating healthcare workers is crucial to protecting LTCF residents who have an elevated risk of severe illness due to COVID-19.⁵

Due to the rapid COVID-19 vaccine rollout with the EUA, there are currently no requirements for LTCFs to report the number of vaccinated staff or residents under the Utah Administrative Rule. However, Utah Code 26-1-30 allows for the collection and dissemination of data to the public regarding population health, risks, and activities which promote public health. Increasing COVID-19 staff vaccination is an essential part of a comprehensive patient safety program. Additionally, providing COVID-19 vaccination data to the public is an important step in creating transparency for healthcare safety and quality in Utah.

The information in this report is collected from data voluntarily reported by LTCFs on the number of staff and residents who were eligible for COVID-19 vaccination before March 12, 2021. Data were collected from the Utah REDCap Reporting System, and are complete at the time of report generation.

The report contains the following data:

- Facility-reported data to the Utah Department of Health (UDOH)
- A comparison of LTCF data by public health district

Key Findings

This report was developed by UDOH. The information in this report is collected from data reported by LTCFs on the number of staff and residents who were vaccinated for COVID-19. COVID-19 vaccination rates were determined by collecting data on the number of staff at each LTCF and the number of staff who were vaccinated for COVID-19. Vaccination rates were calculated by dividing the number of staff vaccinated by the total number of staff, those who were ineligible for the vaccine due manufacture restrictions, such as age or previous allergic reaction to a vaccine, were subtracted from the denominator. This process was repeated for residents.

Recommendation

UDOH recommends that all LTCFs in Utah implement a policy of promoting COVID-19 vaccination for all staff and residents, unless an organization has achieved a vaccination rate greater than 75% by other means.

Notations

Throughout this report, the following notations are used to describe the comparison data in tables 5–26 for each public health district.

Long-term Care Facilities (LTCFs)

Long-term care facilities include: nursing, skilled nursing, and assisted living facilities, with or without memory care. Facilities for individuals with intellectual disabilities (IID), intermediate care facilities (ICF) are not included.

Number of Staff

Total number of staff employed in the LTCF, including all staff and contracted workers.

Vaccinated Staff

Total number of staff employed in the LTCF who completed the 2-dose COVID-19 vaccine series by March 12, 2021.

Vaccination Percentage

Vaccination coverage levels of staff or residents who received COVID-19 vaccine by March 12, 2021.

The **red line** on tables in each health district indicates facilities falling below the targeted 75% vaccination coverage recommended by The American Health Care Association and National

Center for Assisted Living (AHCA/NCAL) in conjunction with the Centers for Disease Control and Prevention (CDC).

Limitations of the data

LTCFs are currently not required to report vaccination numbers of staff or residents under the EUA due to the novel nature of COVID-19. In addition, staff are not required to report their COVID-19 vaccination status to their employer. LTCFs included in this report volunteered this information upon request from the UDOH.

LTCF data for healthcare workers is extremely limited. LTCFs track the number of vaccines given to healthcare workers, but many of these individuals were vaccinated elsewhere and were not required to provide vaccination documentation at the time of this data collection. Therefore, the vaccination data reported may not fully capture the true percentage of staff who are vaccinated.

The data reported are aggregate calculations of vaccination rates over a period of time spanning from December 15, 2020 to March 12, 2021. Vaccines became available to LTCF staff and residents on December 15, 2020; however, vaccination clinics began in LTCFs on December 26, 2020. Additionally, staff and resident turnover during this time may affect the accuracy and reliability of vaccination data. Finally, many healthcare staff work at multiple facilities and may be counted more than once.

Introduction

COVID-19 is a contagious respiratory illness caused by the SARS-CoV-2 virus. It is primarily spread through an infected person's respiratory droplets when a person talks, coughs, or sneezes.⁶ It can cause a wide variety of symptoms. While some infected individuals might not have symptoms, others may experience severe illness resulting in hospitalization or death. Individuals with underlying medical conditions and adults 65 years of age and older have an increased risk of severe illness. As of March 12, 2021, COVID-19 in Utah accounted for 45.5% of hospitalizations in individuals 65 years of age and older.

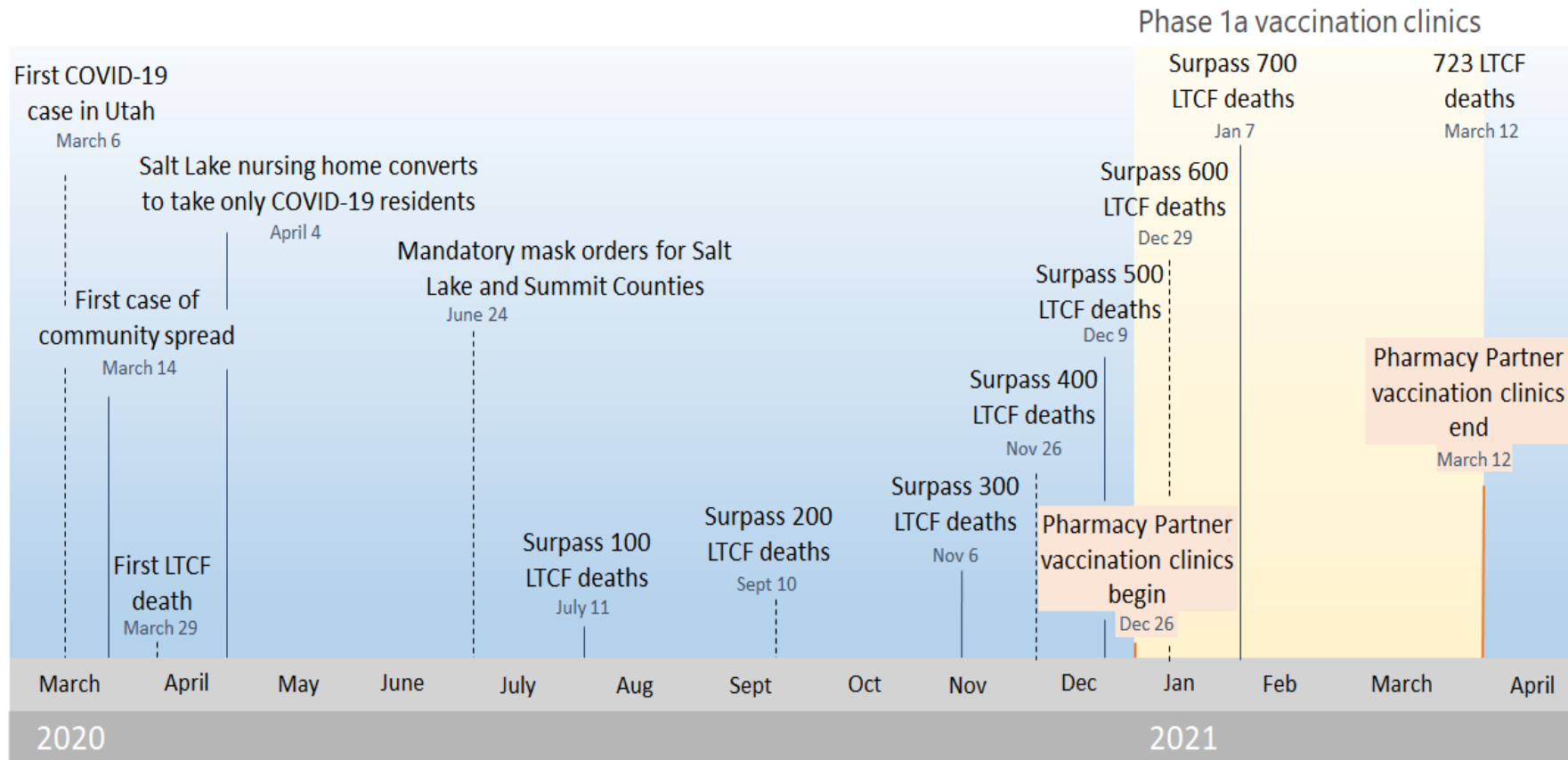
Healthcare professionals (HCP) and support staff represent 10.3% of an estimated 148 million employed adults in the United States.⁷ HCP and support staff are at increased risk of workplace exposure to SARS-CoV-2 because they work closely with residents, facility staff, and infectious materials.^{2,8} Once infected with SARS-CoV-2, they can transmit the virus to residents, coworkers, and members of their own community beyond their workplace.⁹ By the end of Phase 1a vaccination clinics, Utah had approximately 5,080 resident cases, 5,034 staff cases, and 712 deaths reported among LTCF residents, accounting for 34.7% of all COVID-19 deaths in Utah.

Apart from the risks of direct infection, quarantine and isolation increases the risk of mental health disorders such as burnout, anxiety, depression, insomnia, and post-traumatic stress disorder.¹⁰ LTCF staff also experience higher levels of stress related to decreased income due to lost work hours.^{9,11} Similarly, the reduction in workforce in hospitals and LTCFs leads to an increase in the workload and stress of the remaining HCP and to a decrease in the quality of care provided by them to their patients and residents.¹²

Transmission of COVID-19 can be reduced by wearing a mask, physical distancing, avoiding crowds, washing hands often, and getting the COVID-19 vaccine. Vaccine uptake of 75% is recommended by AHCA/NCAL to protect residents and staff and continue the trend of decreasing COVID-19 cases in LTCFs.¹³

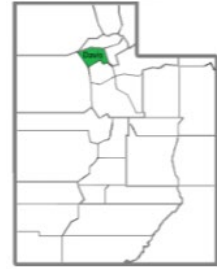

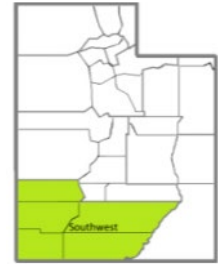

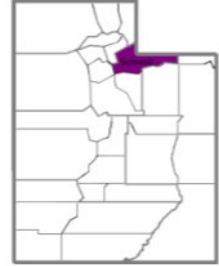
