Notes for Figures and Tables

While reviewing the information provided in the Figures and Tables that follow, it is important to note the following considerations:

- 1. **Information by date of diagnosis** HIV infections and AIDS cases shown in Figure 1 are based on the date of diagnosis by the health care provider. That is, cases of HIV are classified in the year they are diagnosed based on the date of Western blot testing.
- 2. Information by date reported to the Health Department Most of the other figures and tables show HIV and AIDS morbidity by date first reported to the Utah Department of Health. This means that HIV infections are shown in the year they are first reported regardless of whether they became AIDS at a later date. This allows us to assess the impact of new infections for each year. AIDS became reportable August 1983. HIV infections became reportable April 1989.
- 3. **Time period** The majority of the figures and tables compare the 1998-2001 time period to the 2002-2005 time period. All figures and tables are statewide.
- 4. **In this report** cases of HIV and AIDS in women are examined by comparing mode of transmission, race/ethnicity, and age groups by two different time periods. Because only 156 women are included, various groupings may have been combined for confidentiality reasons. Because of low numbers in some categories, it may be difficult to identify valid trends and data should be interpreted cautiously.
- 5. **Out-of-state cases** Out-of-state HIV/AIDS morbidity are not included in this analysis. During the 1998-2001 time period, 162 out-of-state cases were reported to the Utah Department of Health, of which, 32 (20%) were women. During the 2002-2005 time period, 228 out-of-state cases were reported, of which, 34 (15%) were women. Demographic data by age group, race, and risk appear similar to Utah HIV/AIDS cases.
- 6. **Wasatch Front** includes the following counties: Weber, Davis, Salt Lake, and Utah.

Executive Summary

In Utah, 18% of HIV infections and 10% of the AIDS cases occur in women. During the 1998-2005 time period, there were 156 cases of HIV and AIDS reported among women.

During the 1998-2005 time period, the risk for most women reported with HIV and AIDS was heterosexual contact (31%), followed by injecting drug use (28%), and heterosexual contact with an injecting drug user (11%).

Most HIV infections and AIDS cases reported among Women were White non-Hispanic (44%). Black Women accounted for 27% of cases and Hispanic Women 22%.

During 1998-2005, most cases of HIV and AIDS among women in Utah were reported in the 20-39 age groups (69%). During the 2002-2005 time period, increases were reported in the 30-39 and 40-49 age groups.

Most HIV and AIDS cases in Utah occurred among White non-Hispanic women. However, the number of cases that occurred among Black and Hispanic women was disproportionate to the size of those two populations, meaning the risk for HIV and AIDS for women in those populations is higher. During the 1998-2001 time period, cases per 100,000 women was higher among Black women because of a high rate of immigration to the United States of women with HIV infection. However, immigration has declined steadily since 2001.

During the 1998-2005 time period, the majority of women reported with HIV and AIDS in Utah were from the United States (57%), 21% were from the African continent, and 8% were from Mexico.


Ninety-two percent of the women reported with HIV and AIDS during the 1998-2005 time period lived along the Wasatch Front.

Sixty-nine percent of women reported as heterosexual contact, and 70% of women reported as having injected drugs were in the age groups 20-39.

Of the 41 women reported as "Risk not Specified" during 2002-2005, 44% were Black women, 39% were White non-Hispanic women, and 12% were Hispanic women.

During the 1998-2005 time period, women represented 44% of persons tested at counseling and testing sites, but accounted for only 16% of positive HIV test results.

In Utah, 18% of HIV infections and 10% of the AIDS cases occur in women.

Examining cases of HIV and AIDS by year of diagnosis can provide a measure of incidence that is not biased by reporting delay. Based on the date of diagnosis, occurrence of HIV/AIDS among women peaked in 1990 with 33 cases and has fluctuated since that time (between 28 and 9 cases). The average number of women diagnosed during the 1984-2005 time period is 17 cases per year.

Most women reported with HIV and AIDS in Utah are in the 20-39 age groups (69%).

During the 2002-2005 time period, increases were reported in the 30-39 and 40-49 age groups, while case totals decreased among women ages 13-19 and 20-29.




Figure 3. HIV/AIDS Cases Among Women by Risk Category and Four-Year Time Period. Utah: 1998-2005

During the 1998-2005 time period, the risk for most women reported with HIV and AIDS was heterosexual contact (31%), followed by injecting drug use (28%), and heterosexual contact with an injecting drug user (11%).


During the 2002-2005 time period, most women with HIV or AIDS reported heterosexual contact, or injecting drug use (65%). Additionally, 28% of women during this time period were reported as "Risk not Specified".



During the 1998-2005 time period, most HIV infections and AIDS cases reported among Women were White non-Hispanic (44%). Black Women accounted for 27% of cases and Hispanic Women 22% during this same time period.

During the 2002-2005 time period, case totals among White non-Hispanic women increased 34%, while cases among Black women decreased 32%, and cases among Hispanic women stayed about the same.

The number of case reports for Native American and Asian/Pacific Islander women was low; results should be interpreted cautiously.





Figure 7. HIV/AIDS Cases Among Women by Geographic Area, and Four-Year Time Period Utah: 1998-2005




During the 1998-2005 time period, most women with heterosexual risk were White non-Hispanic women (42%), 27% were Hispanic women, and 21% were Black women.

During 2002-2005, HIV and AIDS cases among White non-Hispanic women increased somewhat, while cases among Hispanic and Black women decreased.

Data showing few cases should be interpreted cautiously.

Utah: 1998-2005



During the 1998-2005 time period, most women reported with HIV and AIDS that injected drugs were White non-Hispanic (63%), while Hispanic women accounted for 23% of cases.

During 2002-2005, increases were reported for both White non-Hispanic, and Hispanic women who injected drugs.

Data showing few cases should be interpreted cautiously.



Figure 11. HIV/AIDS Cases Among Women who Inject Drugs by Age Group, and Four-Year Time Period Utah: 1998-2005









Of the 41 women reported as "Risk not Specified," during the 1998-2005 time period, 44% were Black women, 39% were White non-Hispanic women, and 12% were Hispanic women.

During the 1998-2001 time period, 10 (53%) of the 19 women in this category were from Africa, and 6 (32%) were from the United States. During 2002-2005, 11 (50%) of 22 women were from the United States, and 7 (32%) were from Africa.

Figure 15. HIV/AIDS Cases Among Women with Risk Not Specified by Age Group, and Four-Year Time Period Utah: 1998-2005





Seventy-two percent of women testing HIV-positive reported either sex with a partner at risk, or injecting drug use.


